In the past two years the Macon County Continuum of Care underwent a radical transformation with the specific purpose of obtaining input and guidance from a wider range of persons and organizations. The CoC governing board added representation from Millikin University, the Salvation Army, Oasis Day Center, and the Good Samaritan Inn. With the exception of the university, these groups all are in closer day-to-day touch with the homeless population and bring fresh energy and a clear perspective. As a direct result, we have adopted a targeted strategy to end chronic homelessness that relies on identification, assessment, tracking, and outcome metrics. While not a direct provider of service, the university has contributed student internships, research expertise, and a sophisticated knowledge of statistics to our CoC. We have accomplished this while maintaining full engagement of victim services and youth providers.

The CoC assigns responsibility for strategies to efficiently use existing expertise, rather than creating duplicative structures. Responsibility for creating and implementing strategies for the goal of ending veteran homelessness by the end of 2015 is given to the Coalition for Veteran Concerns, an effective collaboration of veterans' groups, advocates, businesses, developers, SSVF, and private citizens. As a result, veteran homelessness has been reduced to near zero.

The primary responsibility for ending chronic homelessness by 2017 is assigned to the Chronic Homeless Action Team, which consists of agencies who do direct street-level engagement with the hardest-to-reach populations. This group is implementing a series of activities to address this goal.

The Board of Directors retained responsibility for planning strategies to end family and youth homelessness by the end of 2020, and for creating a path to end all remaining homelessness.

1B-4. Explain how the CoC is open to proposals from entities that have not previously received funds in prior CoC Program competitions, even if the CoC is not applying for any new projects in 2015. (limit 1000 characters)

The Decatur and Macon County CoC works hard to assure that new entities have a fair chance to receive HUD CoC funds. Our tactics include broadening the leadership of the CoC's Board of Directors well beyond the confines of HUD-funded agencies (see response to 1B-1a). This has transformed the Homeless Council into the functioning focal point of the community's battle against homelessness, rather than merely a "HUD club."

But the tactics extend further. We post website announcements and send emails to all CoC member organizations promoting the opportunity to apply for new projects and describing eligible new projects. We make announcements not only at CoC meeting but at other community networking meetings. Finally, we make presentations to civic and church groups throughout the year. In these presentations we explain and advocate for the Housing First approach and urge those in attendance to consider developing permanent supportive housing rather than creating more shelter beds.

The CoC is an integral part of the Consolidated Plan development and implementation. The CoC's chairperson served on the City of Decatur's Consolidated Plan team during the development of the 2015-2019 plan; this team met at least twice monthly during the 6-month period when the plan was created and submitted. The City official responsible for the Consolidated Plan is an active member of the CoC's Board of Directors and attends our monthly meetings. A Millikin University professor who serves as consultant to the CoC was the primary consultant to the City for the Consolidated Plan. The CoC's data and analysis of PIT and HIC was inserted verbatim into the Consolidated Plan and was the foundation for the Plan's section on homelessness.

The City of Decatur does not directly receive ESG funds from HUD. Funds flow from HUD through the State of Illinois Department of Commerce and Economic Opportunity. However, the CoC makes allocation recommendations, and the CoC Board of Directors provides input into the funding decisions. In this community, all ESG funds currently are awarded to the Salvation Army, which operates an emergency shelter and other services for persons experiencing homelessness. The Salvation Army is moving towards integrating its programs into the Housing First model, and it has a representative on the CoC's Board of Directors

The CoC collaborative applicant, Dove Inc., is the state-recognized domestic violence provider for the geographic area covered by the CoC. Dove is also the applicant for the SSO Coordinated Entry center for CoC and ESG projects. Coordination is virtually automatic. The Coordinated Entry center screens all incoming persons for possible domestic violence and stalking. Anyone indicating domestic violence is immediately referred to Dove's Domestic Violence Program for shelter, legal advocacy, safety planning, and other services. The Domestic Violence Program is founded on client choice, and its services integrate this principle throughout.

No data are entered into HMIS that would identify domestic violence survivors. The Dove Domestic Violence Program is funded currently by HHS, the State of Illinois, churches, the county mental health board, and private donations. In the past it has received funding from the Department of Justice (VAWA), and ESG.

Three developments offer permanent supporting housing for persons experiencing homelessness, Harbor Place, owned by Dove, has eight units, all dedicated to homeless families with children, The Elmwood Apartments, developed by Dove in cooperation with First Presbyterian Church, have eight units for families and individuals, all dedicated to persons who are homeless. In addition, the community has a 17-unit non-CoC funded transitional housing complex that is used 100% by families and individuals experiencing homelessness. The CoC/ESG Coordinated Entry center screens, admits, and places homeless households directly into all the above developments.

In addition, two other subsidized housing complexes, Camelot and Charles Street, reserve two units each for persons experiencing homelessness.

We are working to fill these two notable gaps – foster care and health care. The issue of children aging out of foster care has recently re-emerged. We had a solution in place – a supportive housing development that served this population exclusively. It was sufficient, given the small number of homeless youth in our area (see Section 3B-2.6). However, it abruptly closed in the past few weeks due to the State of Illinois cutting funds for human services. Our CoC is working with local child care organizations to assess and find a way to meet this need.

In the area of health care, we have invited representatives of the two Decaturbased hospitals to join the CoC's Board of Directors to work with us on coordination of discharge planning so that no patients leave these institutions without a place to call home.

Based on the recent Coordinated Entry Policy Brief, HUD's primary goals for coordinated entry processes are that assistance be allocated as effectively as possible and that it be easily accessible regardless of where or how people present for assistance. Most communities lack the resources needed to meet all of the needs of people experiencing homelessness. This combined with the lack of a welldeveloped coordinated entry processes can result in severe hardships for persons experiencing homelessness who often face long wait times to receive assistance or are screened out of needed assistance. Coordinated entry processes help communities prioritize assistance based on vulnerability and severity of service needs to ensure that people who need assistance the most can receive it in a timely manner. Coordinated entry processes also provide information about service needs and gaps to help communities plan their assistance and identify needed resources.

1E-1. Explain how the CoC's coordinated entry process is designed to identify, engage, and assist homeless individuals and families that will ensure those who request or need assistance are connected to proper housing and services. (limit 1000 characters)

Our SSO project, Homeward Bound, is the Coordinated Entry point for the entire geographic area. It has functioned as a coordinated assessment center since the CoC was organized in 1994. It is well known among churches, food pantries, human service providers, mainstream programs, and others. As shown on Table 1E-2, every system in the community refers to Homeward Bound. It has a fully accessible walk-in office on the edge of the central business district. We use the ETO (Efforts to Outcomes) uniform assessment at intake and place persons in immediate housing whenever possible.

Homeward Bound advertises through public services announcements and news releases, including promoting events such as "Box City" during Homeless Awareness Week (when groups camp overnight in appliance boxes), PIT counts, and speeches to churches, civic groups, and schools. Homeward Bound staff also physically go out to places where homeless people are reported to be living to conduct street-level outreach.

The committee also gave priority consideration to families with children and those who might have problems accessing housing or services due to other barriers, such as language and poor credit.

In early 2015, the CoC Board of Directors implemented a thorough project monitoring system to provide real-time data to the Board and to all projects. On a monthly basis, the CoC Board received a statistical report that includes: utilization, HMIS data quality, and housing outcomes (e.g., placements in housing broken down by housing type, and housing retention/exits). This information is provided for the system as a whole and for individual projects.

Using HMIS, the CoC also generates monthly project-level reports that contain additional data: length of homelessness, housing stability, eligibility, length of stay, destination at exit, and income status for employment and non-employment sources. The CoC also monitors the timely submission of APRs and regular draws.

These data are used primarily to identify needs for technical assistance but can also be used to spot projects that consistently fail to meet standards and expectations of the CoC.

HMIS bed coverage in emergency shelters and transitional housing 50% and 43% respectively. This is a serious issue in our continuum. In the Emergency Shelter component, the problem centers on four faith-based groups with a total of 49 beds. The transitional housing problem is due to one of the same agencies with 94 beds.

Unfortunately, these groups have resisted all of our attempts. However, most of them did participate in the PIT and HIC in January 2015. The problem is compounded by their low utilization rates, which clients attribute to forced participation in religious services and – in one case –requiring clients to turn over their food stamps. We will continue our attempts to involve these groups. If our FY 2015 Planning Project is approved, we will create a marketing plan to expand HMIS beyond its current users in order to improve the data upon which we base our CoC's planning efforts.

The CoC trained staff members from every emergency shelter and transitional housing project on how to complete the survey accurately. For the sheltered count, surveys were distributed a few days before PIT night to every emergency shelter and transitional housing provider in the county, and we achieved 100% coverage. Our first line of defense is "points of entry" into homelessness. In addition to the Coordinated Entry center, these include schools, Northeast Community Fund, Salvation Army, Oasis Day Center, and the Good Samaritan Inn. We have trained staff at these agencies to intervene and prevent homelessness when possible.

The second line of defense is to provide direct assistance to divert persons from homelessness: rental assistance, domestic violence legal advocacy, and behavioral health services. Partners responsible for this are Dove Domestic Violence Program, the Salvation Army, and Heritage Behavioral Health Center.

We use the ETO assessment and intake interviews to identify and categorize vulnerabilities and risks. Major risk factors are sudden loss of income, domestic violence, poor health, untreated mental illness and substance use disorders, and criminal history. This process creates prompt responses to those with greatest needs.

To reduce the rate of returns, we employ three strategies: (1) we identify barriers that increase risk of return such as a high ratio of housing costs; (2) we arrange for long-term warp-around case management by an external agency whenever possible; and (3) we offer in-house Life Skills classes to increase income and employability.

Our HMIS tracks all clients from their point of entry into any project within the system, and their records stay in the CoC-wide system permanently. Using HMIS, we can identify if, when, and where they return. An example: A family exits transitional housing for permanent housing, and two years later, they appear at our SSO and are homeless. HMIS will track how long they were housed, which project they last exited, and the date and agency at which they reappeared in the system.

Our strategies for increasing household income spring from our Life Skills classes. We employ two strategies to boost employment income: (1) an Employment Specialist funded by United Way and the Illinois Department of Human Services teaches sessions in resume building, interviewing and other soft skills; and (2) we have a cooperative referral arrangement with the county Workforce Investment Act provider growing out of a pilot program (see 3A-6a).

To generate gains in non-employment income, we send regular email blasts to all partners reminding them of eligible standards and application processes. We have a goal of 100% enrollment.

3A-6a. Describe how the CoC is working with mainstream employment organizations to aid homeless individuals and families in increasing their income.

Every mainstream employment organization in the community is represented on the CoC. We have a particularly close working relationship with the county Workforce Investment Act administrative agency, Workforce Investment Solutions (WIS). In FY 2013 we partnered with WIS in a pilot effort, part of a national homeless-to-work project funded by the Butler Family Fund. This project, Connect to Work (see www.connecttowork.org), identified over 80 promising practices used by the best programs in the country.

In Decatur and Macon County, our CoC and WIS developed a unique cooperative referral and case management program. This project was designed so that CoC Case Managers and WIS Employment Counselors jointly engaged in creating self-sufficiency plans for clients and jointly tracked client progress as they moved through WIS-provided training and employment preparation. This project was eventually merged into the CoC's current Life Skills program.

To engage those with disabilities we partner with Soyland Access to Independent Living, and we have translation services for those with limited English proficiency. To reach rural areas, we partner with the Sheriff's Office, church-sponsored food pantries, and township General Assistance supervisors. These partners identify unsheltered homeless, and our workers make contact in the field.

We utilize the Chronic Homeless Action Team for persons living on the streets. CHAT's primary goal is to get people off the streets and into permanent housing whenever possible. When that is not possible because of shortage of available housing units, CHAT places them in shelters. When even that is impossible due to refusal of services, CHAT tracks their progress toward engagement using the evidence-based Stages of Change model. CHAT reports their housing placements as well as their Stages of Change classification to the CoC Board of Directors on a monthly basis.

We are concerned by the increase in the number of chronically homeless persons counted in the 2015 PIT. We suspect one issue might be in the wording of our PIT survey instrument, which does not carefully define the term "homeless" when it asks if persons have been homeless for 12 consecutive months or four times in the past three years. We may be counting persons who use a less specific definition, such as couch-surfing and doubled-up. We will correct this in the 2016 count. Another possibility is lingering effects from record unemployment experienced 2-3 years ago (unemployment can lead to homelessness, but rarely is it immediate).

The unsheltered count decreased slightly, from 26 to 22. We hoped for a much more substantial decline. As a result of this slow progress, we have implemented the CHAT team approach to identify and track all chronically homeless persons (see 3A-7 and other responses).

The number of CH beds will decline markedly from FY2013 to FY2014, due to our counting prioritized CH beds towards the total CH tally in the 2013 HIC, when HUD had no category for prioritized CH beds. Please note: This is NOT a decrease in the number of actual beds available for CH, but only a change in how they are counted.

As a small community, Macon County has a relatively low number of chronically homeless, with 15 adult individuals, and 16 persons in families identified as CH in the 2013 PIT. This calls for a nontraditional approach to ending chronic homelessness. Our customized 24-month strategy has two prongs:

- (1) We will identify CH families with children and place them immediately into safe and secure housing. In fact, after 6 families were counted in PIT, 3 of them were housed within days.
- (2) Because the remaining CH adult individuals have repeatedly declined housing offers, we will use evidence-based "stages of change" and "harm reduction" models to engage them, trusting that this approach will lead them to accept housing.

- (2) The CHAT team has fully implemented the Stages of Change and Harm Reduction models to engage chronically homeless persons who are resistant to engagement in the system. As mentioned in 3B-1.1a, we are very concerned about the increase in the PIT chronic homeless count. We are currently not on track to end chronic homelessness in our community in the next two years. We are implementing two strategies and allocating resources to them:

- (1) With the assistance of Millikin University, we are modifying our PIT survey instrument to obtain a more accurate count. The revised survey will carefully define homelessness so that persons who have been couch-surfing or doubled-up in past episodes will not count as chronically homeless.
- (2) We have implemented the CHAT team. As explained previously, this team has identified by name all chronically homeless persons in the CoC, and is tracking their movement and progress, with the goal of getting each of them into stable housing.

We have implemented a new RRH project in the FY 2014 CoC competition, and we are reallocating funds from a transitional housing project to create another RRH project this year. These will provide a total of 8 new RRH units.

The plan to re-house families has four elements:

- (1) Homeward Bound SSO (the Coordinated Entry center) keeps an inventory of available beds and units in real time (ES, TH, and PH), and emails the inventory daily to CoC members.
- (2) When a family PH unit is available, Homeward Bound SSO places the family with the most needs and vulnerability in that unit, using our Housing Prioritization policy to give preference to those listed in 3B-2.1 above.
- (3) If a unit is not available, Homeward Bound SSO seeks another PH unit on the open market.
- (4) If none is open, the family is placed in transitional housing or a shelter.

The total number of households with children declined by only one from 2014 to 2015, going from 24 to 23. While this small decrease is not acceptable to our CoC Board, we were encouraged that only one family was unsheltered in the 2015 PIT compared to 4 in 2014. The reason for the slight overall decrease is more aggressive outreach and advertisement of the Coordinated Entry system. However, our efforts have clearly not been sufficient to reduce the level of need to an acceptable rate. The reason for the decrease in unsheltered families with children is better utilization of existing shelters and transitional housing projects.

Our CoC has a close relationship with LEAs. In Illinois, the role of the SEA is delegated to Regional Offices of Education. The educational homeless liaison for the Regional Office of Education serves on the CoC's Board of Directors. The homeless liaison for the largest school system, Decatur Public School District #61, is active on the CoC. At the building level we also work with Parent Liaisons, along with school nurses and social workers (see 3B-2.11). Furthermore, the lead consultant to the CoC is an elected member of the Decatur School Board and serves as a vocal advocate for children in homeless families within the public education system.

At the systems level, the liaisons work within the school districts and the CoC Coordinated Entry center to assure compliance with our existing policies and to assure seamless referrals, assessments, and housing placements.

3B-2.11. How does the CoC make sure that homeless participants are informed of their eligibility for and receive access to educational services? Include the policies and procedures that homeless service providers (CoC and ESG Programs) are required to follow. In addition, include how the CoC, together with its youth and educational partners (e.g. RHY, schools, juvenilee justice and children welfare agencies), identifies participants who are eligible for CoC or ESG programs. The CoC policy provides that: (1) Students who are homeless remain in one school if it is in their best interest; (2) Schools provide transportation; (3) Homeless children and youth enroll and attend immediately, even if they cannot produce required documents; (4) Children in homeless households have access to the full range of opportunities including extracurricular activities, pre-school and early childhood development, and special education; (5) Homeless providers offer stable, permanent housing and supportive services; (6) Homeless providers consult with the homeless liaison for the children's school district to assure the least possible interruption in education; (7) School personnel and designated homeless liaisons consult with the CoC to assure that interventions are offered for immediate housing and services; and (8) School liaisons and homeless case managers jointly develop and review plans.

The educational homeless liaisons refer all homeless families to the Coordinated Entry center for assessments and determination of CoC eligibility. Parent liaisons at the building level, along with school nurses and social workers, work directly with the CoC's Coordinated Entry center to assure that eligible families are served.

The referrals also work in the other direction. When a CoC provider encounters a family with children, the provider contacts the educational liaison as well as the home school (including preschools and the special education district as applicable). The provider follows up to assure that parents and children are informed of eligibility for educational services, and that the services are delivered. Critically, we avoid moving children to a new school whenever possible, and the school district offers transportation.

Our CoC area has a very small number of homeless veterans, and is decreased from 17 to 10 from 2014 to 2015. We were also pleased that the number of unsheltered veterans declined from 8 to 4 in the same period.

We attribute the small number of homeless vets, as well as the decrease in unsheltered homeless veterans, to the active work of the Coalition for Veterans Concerns (CVC), a group started with the help of the CoC several years ago. This collaborative group has developed veterans housing through a private developer (D&O Properties), obtained HUD-VASH vouchers through the PHA, initiated an SSVF program through Salvation Army, and created a fulltime veterans outreach position within Lutheran Child & Family services. As a result of this activity, we will end all veteran homelessness this year.

Using the ETO uniform assessment tool, staff at the Coordinated Entry center asks questions that identify veterans. We refer all veterans to the SSVF (Supportive Services for Veteran Families) program operated by the Salvation Army. Staff at the Coordinated Entry center do not determine if veterans are eligible for VA services; that decision is made by SSVF. If a person is eligible for VA services, SSVF staff work with the PHA to obtain HUD-VASH vouchers and with D&O Properties to place the veteran in housing.

Similarly, staff at SSVF do not attempt to determine if a homeless veteran is eligible for CoC or ESG services. They refer veterans to the Coordinated Entry center for us to make that determination. In this way, each agency "stays in its lane" and uses its expertise.

3B-3.3. For Veterans who are not eligible for homeless assistance through the U.S Department of Veterans Affairs Programs, how is the CoC prioritizing CoC Program-funded resources to serve this population? (limit 1000 characters)

As mentioned in the previous response, we do not determine if a veteran is eligible or ineligible for VA assistance; that determination is made by VA-related organizations. What typically happens is that we refer all veterans to SSVF or VAC. When they determine that a veteran is not eligible for their services, they notify the CoC via our Coordinated Assessment center, and we plug that veteran back into our system of housing and services.

They receive priority attention, but it is important to state – even if it costs us points in this response – that our guiding set of priorities is that found in HUD Notice CPD-04-012, issued on July 28, 2014.

The CoC collaborates with three partner organizations that specialize in enrolling persons in health insurance, including PPACA – especially the expanded Medicaid program in Illinois. The main resource is the Macon County Health Department, which has produced outstanding outcomes. In all, it has enrolled over 1,700 persons, including many homeless, in PPACA coverage since January 1, 2014. As one example, the Health Department enrolled 38 homeless persons in a single onsite event at the Good Samaritan Inn, a meal site. In addition to the Macon County Health Department, other partners that enroll persons are the Decatur Macon County Opportunities Corporation and Heritage Behavioral Health Center.
