While it is possible some of these households were in fact homeless, most are likely to either reside in permanent housing or group homes (such as through Heritage Behavioral Health Center or Woodford Homes), or chose not to disclose where they stayed. Also, persons who spent the night in prison, the hospital, Heritage's emergency detox unit, or with a motel voucher provided through IDOC were not considered homeless.
